Leaving Certificate Examination 2019 ***Art – Coursework Component***

The accompanying brief *M62/67*, containing the ***Instructions to Candidates*** provides clarification to Art teachers, to principals and to all candidates of the procedures to be followed in the selection and execution of coursework for Art for the Leaving Certificate Examination, 2019.

The teacher of Art should ensure that each candidate:

- receives an individual copy of the Coursework Brief containing the ***Instructions to Candidates, 2019***
- receives an individual copy of the Coursework Workbook
- is familiar with the ***Instructions to Candidates, 2019***
- complies with ***all*** the requirements outlined in the ***Instructions to Candidates, 2019***
- selects coursework within her/his competence and which can be completed using only the equipment and materials available in the school
- discusses and agrees the coursework in advance with the teacher
- selects coursework which can be completed within the supervised time available in the school
- is aware that group projects are not acceptable and accordingly submits a separate and distinct project for assessment
- is fully aware that the coursework must not be removed from the school setting under any circumstances, as doing so will result in the coursework being considered invalid
- understands that no marks will be awarded for coursework which does not fully comply with the ***Instructions to Candidates, 2019***
- is aware that the teacher and principal can only sign off and authenticate coursework which is fully compliant with all the requirements outlined in the ***Instructions to Candidates, 2019***.

The assistance of School Authorities and teachers of Art in maintaining the integrity of the assessment process is very much appreciated by the State Examinations Commission.

Please ensure that this notice is brought to the attention of the teachers of Art and that each candidate receives a copy of the enclosed *Brief*.
