1. Practical Coursework should be executed in the school under the supervision of the teacher.
2. Teachers should monitor the progress of the candidates' Practical Coursework on a regular basis.
3. Practical Coursework submitted for assessment must be the candidates' own individual work.
4. The closing date for completion of projects is **9<sup>th</sup> April, 2018**.
5. In the case of repeat candidates new Practical Coursework must be undertaken and presented for assessment.
6. Candidates must present themselves for an oral assessment, as stated in the Rules and Programme for Secondary Schools.
7. **All candidates must be available for interview during the monitoring process.** However, a sample of candidates will be chosen for interview.

**N.B. Please ensure that a Form P3 is completed and submitted in respect of candidates who are doing Ag. Economics Coursework in a school/centre other than the school/centre where they are entered.**
